

Immunization Resources for Pierce and Southern King Counties – Dec. 2022

COVID VACCINATIONS:

- **Tacoma Pierce County Health Department** has a static COVID-19 clinic at Lakewood Towne Center which vaccinates children **ages 6 months and older**. Drop-ins and appointments are offered. To make an appointment: <https://covid1ts.simplybook.me/v2/#book>

- **Public Health Seattle King County** has a COVID vaccination clinic at the Auburn Outlet mall which is on several transit lines that can vaccinate children **ages 6 months and older**. They also have additional clinics and events in the community.

Additional options:

- Children **ages 18 months and up** can receive their COVID vaccinations at CVS Pharmacy.
- Children **ages 3 years and up** can receive the COVID vaccinations at **ANY** retail pharmacy (Bartell's, Safeway, RiteAid, Walgreens, Costco).

FLU VACCINATIONS:

- Children **ages 3 years and up** can receive their flu vaccine at **ANY** retail pharmacy. There may be a co-pay, and Apple Health families may have to pay out of pocket. Some pharmacies offer premiums (Safeway - 10% off groceries, Bartell's - Free Teddy Bear, Target - Gift card) for getting your flu vaccine, so families may wish to look for the best deal out there.
- **SeaMar Community Health Clinics** offer fly walk-in vaccinations on a first-come, first-served basis for un- and underinsured children. An administrative fee may be charged, but no one is turned away for lack of funds. Locations for SeaMar clinics: <https://www.seamar.org/seamar-clinics.html>

VFC/SCHOOL AGE VACCINATIONS:

In addition to Mary Bridge Mobile Immunization Clinic, children ages 4-18 who are uninsured, underinsured, on Apple Health Insurance (Medicaid) or Washington Children's Health Insurance Plan (CHIP) or uninsured also these two options available:
